## Second Round of the IAI Small Grant Program (SGP II)

In response to the announcement of the second round of the IAI Small Grant Program (SGP II) eighty eight proposals were received by the deadline (18 August 2003). The total budget available for project under this program is US\$ 600K. Individual grants are up to US\$ 30K. The total budget request was US\$ 2,512,527. The IAI intends to fund approximately 20 proposals under SGP II.

Prior to the three-step peer review all proposals were checked by the IAI Directorate for completeness of submitted documentation. Two proposals were disqualified due to incomplete documentation (no main proposal included). The remaining 86 proposals (41 Research, 42 Workshop, 3 Technical Report) proceeded into the review process.

The proposal review applied was the established IAI three-step peer-review process, including mail, panel and IAI SAC review. While the mail review assessed the scientific excellence of the proposals, the panel review considered additional aspects, e.g., multinational collaboration, contribution to capacity building, appropriateness of budget. For each proposal at least three mail reviewers were approached. In quite a number of cases there was either no response by the mail reviewers, or reviewers declared a Conflict of Interest. In case of proposals with no mail review, the scientific review was done by at least two panelists. The IAI Directorate continued to approach mail reviewers for responses until the end of the panel review.

The review panel convened in Sao Jose dos Campos, Brazil from 20-22 October 2003. The panel was composed of four external scientists and three members of the IAI SAC with different areas of expertise. Additional expertise was included by the mail reviews received. The panel was chaired by the IAI SAC Chair. All eighty six proposals were reviewed by the panel. Each panelist took the lead on several proposals in/close to her/his field of expertise and introduced those proposals to the group. The review criteria applied by the panel were scientific excellence and technical soundness, regional collaboration, contribution to capacity building, policy relevance, appropriateness of budget.

Applying a five increment rating scale (1=poor, 5 = excellent) the panel ranked 48 proposals as fundable ( $\geq$  3.4) and recommended those to the Scientific Advisory Committee (SAC) with a total budget of US\$ 1,369,361. The remaining 38 proposals were not recommended for funding.

The SAC met from 3-5 November 2003 in Santo Domingo to prepare a list of funding recommendations to the IAI Executive Council (EC) based on the forty-eight proposals recommended for funding by the review panel. Additionally to the evaluation criteria applied by mail and panel, the SAC also considered the thematic distribution across the themes of the IAI Science Agenda, regional and institutional balance, participation of new groups, new topics.

The SAC recommends to the EC twenty-two proposals (see Table attached), totaling US\$ 612,701 for funding, including two proposals with recommended major budget reductions.
