IAI Director Recruitment

Based on discussions at the EC Meeting on 29 June 2004, a review of the Standing Rules of the Conference of the Parties of the IAI and other considerations, the following appear to be the options for the timing of the next Conference of the Parties (CoP) meetings:

OPTION 1:

If the CoP decides to hold a "Special Meeting", i.e. a second meeting in 2004 (as proposed in December 2004), Rule 11 states, "The Conference of the Parties, in special instances and at the request of one or more of the Parties, may hold Special Meetings. These meetings may be held with two-thirds or more favorable vote...The Party that first tenders and offer shall be the site of the Special meeting, and in the case of no offers, Rule 9 of this Chapter shall apply."

Rule 12 states "A request to hold a Special Meeting must contain an agenda of which only those items contained therein shall be discussed."

Since Rule 7 states, "The Conference of the Parties shall hold one regular meeting a year..." there would still need to be a CoP meeting in 2005.

OPTION 2:

Another option presented would be to hold the CoP in January or February 2005 (possibly in conjunction with the EC which would be postponed from December 2004). It should be noted that the CoP is expected to approve two items in 2005, the Budget and Core Contributions for 2005/2006 and the CRN II awards. While it may be possible to have the Budget and Core Contribution schedule prepared early for consideration by the Cop, it would be virtually impossible for the IAI to have the CRN proposals received and reviewed prior to this date since the Call for Proposals is not expected until January 2005. Thus, a second CoP would be required in 2005 in order to approve the CRN II awards in a timely manner. The following scenario is built around a hypothetical CoP date of February 16-17, 2005, with the election on February 16.

A related issue is the nomination of an Interim Director. The IAI Director Search Committee or a separate committee (to be formed) would be responsible for identifying possible candidates for the position of Interim Director. It should be noted that per Rule 70, "When the position of Director becomes vacant before the term has been completed, said position shall be occupied on an interim basis by the individual designated by the Executive Council for a maximum period of up to six months."
