SUMMARY OF ACTIVITIES

Between June 2011 - June 2012 the SAC met three times in person (Santiago de Chile/Chile, Cuernavaca/Mexico, St. Petersburg/USA) and had monthly teleconferences to advance the IAI Strategic Plan and to design and implement the CRN3 review and selection process.

The SAC reviewed the IAI Strategic Plan developed during the 2010-2011 timeframe, and found that the best way to implement it was to incorporate the most important elements of the Plan into the CRN3 call for pre-proposals and in the final call for CRN3 proposals. Of particular importance was to ensure that the CRN3 teams:

- addressed the overall objectives of the IAI to ensure excellence in science,
- to develop teams from multiple countries in which each country participant had full access to all member facilities
- develop teams in which each team member was considered as an 'equal',
- to address capacity building,
- to engage human dimensions experts in the team
- to develop solid linkages between science and policy options for the region.

Each proposal was required to address these issues.

An external expert, Dr. John Stewart, was invited by the IAI Directorate and the SAC to chair the Proposal Evaluation process for the CRN3 call. The process included:

- drafting and publishing a call for pre-proposals,
- review and selection of pre-proposal teams,
- drafting and issuing a final CRN3 call for proposals with specific guidelines, and

- review and selection of CRN3 proposals.

The SAC received a total of 88 pre-proposals in November 2011. These were reviewed by SAC members and when needed by external experts. Final selection was made during a 2-day meeting in Cuernavaca, Mexico (28-30 November 2011). A total of 32 pre-proposals were selected to move to the final CRN3 round. Each full proposal was assigned to a SAC member and at least three external reviews were sought.

A total of 26 CRN3 proposals were received for final review. The evaluation process was iterative, and took into account external reviews, SAC expert reviews, and SAC deliberations on content and strategic plan relevance. Each proposal was discussed at least twice.

A total of 8 CRN3 proposals were selected for funding. The final statistics of this selection is as follows:
