1) Status of the Core Budget

a) Country Contributions

As of October 31, 2007 the funds collected (cash incomes) represent 53% of the approved contributions for the fiscal year 2007/2008. United States is currently paying their contribution when requested by the IAI, therefore the contribution is shown as pending for 2007/2008 as funds for this fiscal year have not yet been withdrawn.

Table I shows the status of the contributions received as of October 31, 2007.

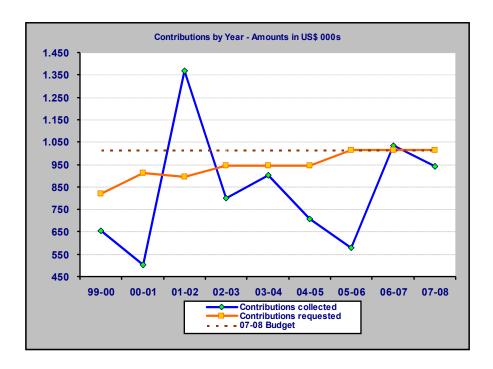

During November 2006 the Member Country Representatives were contacted by the Directorate in order to remind them to request, within their administrations, the payment of the pledged contributions. The response from the countries has been very positive; Peru transferred the total of US\$36,649 and as part of the commitment to pay for previous contributions during 2007. Chile and Brazil paid their contributions for 08/09 in advance before the end of 2006/2007.

At the start of 2007/2008 Chile sent another payment of US\$15,000 to IAI. They already had one year's worth of contributions in advance, and with the additional payment, they would be advancing 3 more years of contributions. We sent them a letter requesting an explanation for the increased amount, specifically asking if Chile had intended to increase their yearly contributions from US\$5,000 to US\$12,000, based on the increase in the OAS participation percentage. We are waiting for an answer to our questions.

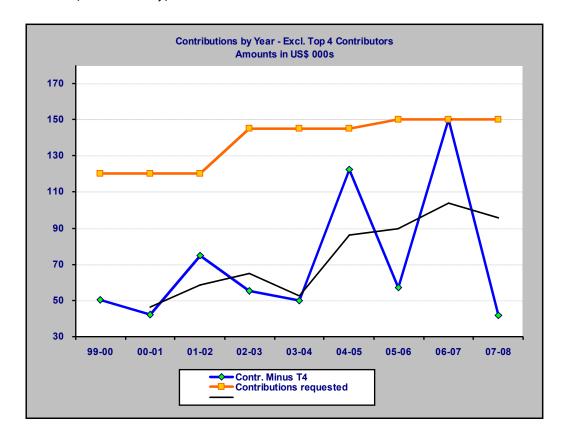
Additional contacts with the member countries were made after the June 2007 Cop/EC Meeting in Manaus, specifically communicating the contribution amounts in place for the 2007/2008 fiscal year. Also, collection letters will be sent to the countries with pending contributions in November 2007.

The following graph shows the Country Contribution's trend since 1999.



Annex 1 shows the history of member country contributions as of October 31, 2007, including expected contributions for 2007.

Excluding the four top contributors to the IAI (Brazil, Canada, Mexico, and USA), the trend of contributions is as follows:



The largest portion of the increase is 2006/2007 is Argentina's contribution to the IAI for a total of US\$100,000; the overall trend has increased slightly since 1999 (black trend line), even though the Institute is fully dependant of the four major contributors.

Four member countries have never paid their contributions to IAI since they became members, do not participate in the IAI meetings and have a very limited, if any, participation in the scientific programs: Bolivia, Dominican Republic, Guatemala, and Paraguay.

Also, Uruguay paid for the first 3 years of IAI, however they have not issued payments since the 1997/1998 fiscal year. Their participation in the scientific programs is also limited, and they do not participate in the IAI meetings.

b) Collection of Country Contributions

In addition to the regular efforts mentioned above, the funding requests have involved all senior members of the IAI staff, with different strategies depending on the situation of each specific country. Important developments have been obtained in the case of Chile and Peru to engage them with IAI activities. Talks with high-level government officials have taken place in Guatemala and Uruguay, but without tangible results so far. Guatemala has never paid its contributions, and Uruguay only once upon joining.

After the visits, contacts were made and the process of engaging Uruguay is under way, with a formal letter to the ministers of S&T and Environment requesting the renewed participation of the country in IAI. This will be to ensure a wider participation of the country's scientists in one of the focus areas of study, the La Plata Basin.

Every opportunity to promote IAI and request funds is used. Whenever there is travel to one of the countries not actively participating in IAI affairs, contacts are made in order to promote IAI with the high level country officials, usually requesting meetings with persons with enough political power and budget, to move towards a decision to engage the country and compromise the funds.

The strategy to engage more countries is based on content driven effort, that is, first creating the local scientific content and then involving local scientists in the IAI's request for contributions. This encompasses not only current members of the Institute, but also potential members, with a focus on the Caribbean and the Central American countries.

Whenever the IAI had communications with member countries (or those not actively participating), a country profile sheet is provided in order to show the tangible benefits that the countries have obtained from participating in IAI. This creates a very positive impact.

We have received encouraging responses from other countries that are not actively participating in IAI, or that are not paying their contributions. This is the case of Bolivia that after contacts with the local scientists involved in IAI, the Ministry of Foreign Affairs of Bolivia has sent the request for payment to the Ministry of Finance.

c) In-kind Contributions by the Host Country

As established in the Host Country Agreement, Brazil pays for several IAI expenses, including facilities, security, car and building maintenance, cleaning, gasoline, computer equipment, four local staff positions, telecommunications, office materials and equipment, among others.

The expenses paid by INPE in the 2006/2007 fiscal year amounted to US\$185,776.30 as follows (numbers provided by INPE Administration):

In U.S. Dollar terms, the Brazilian In-kind contribution remained relative stable, with a slight decrease from years 2004/2005 to 2005/2006, compensated by the increase in year 2006/2007.

In Brazilian real terms however, the contribution has had a decrease of 22.4% from 2004/2005 to 2006/2007, mostly explained by the weakening of the US dollar compared to the Brazilian Real (Average: R\$ 2,72 / 1 US\$ in 2004/2005; R\$ 2,10 / 1 US\$ in 2006/2007).

The amount of the in-kind contribution in 2004/2005 was equal to R\$ 503,027; in 2006/2007 it was R\$ 390,163.

Annex 6 details the contributions per year in both U.S. Dollars and Brazilian Real with the yearly variances.

d) Expenses

The following table shows the expenses year-to-date October 2007 (four months into fiscal year 2007/2008). This comparison shows the status of the four-month core budget compared to the actual expenses in the corresponding period.

These expenses include the provisions for holidays, contributions to social security, and depreciation of fixed assets as of October 31, 2007.

Year-to-date expenses at the end of October 2007 are 9.4% below the four-month budget, with most of the variance coming in the categories of Salaries & Benefits, Travel, and Dissemination & Outreach, as follows:

- Salaries & Benefits: The Pension Plan expenses of the Program Manager, included in the budget as an international employee is governed by Brazilian legislation decreasing actual expenses compared to the budget (US\$11k impact). The rest of the difference is due to lower actual Housing and Education Allowance than estimated in the budget.
- Travel: Staff travel has been reduced being more selective on the events to participate in, therefore cutting cost. Also, the actual expenses show reduced travel in 2007/2008 since the EC/CoP Meetings have not been held at the close of October 2007.
- Dissemination & Outreach: The expenses for this area were lower than budgeted as the expenses for the next issue of the

Newsletter have not been fully incurred. We expect these expenses in the following quarter, therefore matching the budget amounts.

Below you will see the detail by activity of Director's Special Fund expenses during the period from July to October 2007 (Table III):

The activities under the DSF have increased compared to the previous year, when few activities were funded.

2) Cash Composition and Core Budget Reserves

The cash balance on September 30, 2007 was 21.6% lower than the ending balance at the end of fiscal year 2006/2007; expenses continue to be tightly controlled and some countries continue to pay for previous year's contributions, however at beginning of 2007/2008 the IAI has temporarily covered program funds with reserves, before requesting the funds from the NSF, this to avoid high NSF cash balances at the end of the quarter.

In the previous fiscal year, the grant to cover the U.S. Contribution did not open in Fastlane, making it impossible to withdraw the funds. This issue was corrected at the beginning of July 2007, and the funds for the 2006/2007 were partially withdrawn (70%). These funds fall into the 2007/2008 fiscal year cash-flow.

This level of reserves (IAI Core Budget Funds) would cover 4 months of operations with the current annual budget level of \$1,015,000 (Fiscal Year 2007/2008 budget approved by the 14th CoP in Manaus, June 2007). A verbal agreement was reached with NSF Finance, to get the contributions up-to-date within an 18-month period.

If the funds for the U.S. contribution for 2006/2007 and 2007/2008 were taken into consideration in terms of reserves (there is another contribution approved for 2007/2008), the IAI Core Budget Funds would cover 13.3 months of operation at the current US\$1,015,000 budget level, however the weakening of the US dollar in Real terms is likely increase the level of expenses.

The effort to increase the level of contributions by broadening the country base is an on-going process and the results show in fiscal year

2006/2007, with member countries making efforts to participate more actively in the IAI and some of those that had not paid their contributions for some time, are trying to catch up on their commitments.

Alternative funding is also being sought by the Directorate, currently the MacArthur Foundation proposal, the IDRC proposal, and other initiatives have been approved and will expand the IAI's funding base, for projects as well as contributions to the operational expenses of the Institute as part of overheads in the proposals.

These initiatives, and any other in which the IAI is able to engage, require efforts by all the staff of the directorate, as the increased activities will be initiated before the funds arrive, i.e. before any operational relief in terms of additional administrative support. The staff of IAI is committed to make the extra effort in furthering the Directorate's reach and are engaged to assume the increased functions.

3) Status of the Program Budget as of October 31, 2007

a) Collaborative Research Network I (CRN - I)

Although the CRN I program was already officially closed, in February 2007 the Directorate was granted an additional no-cost extension request from the US-NSF to utilize remaining funds for continued synthesis and dissemination of CRN I activities, particularly program results that have become available only after the closure of the program. Under this no-cost extension, the following activities are planned or are being completed:

- Publication of the Spanish version of the IAI-SCOPE book, including translation, editing, proof-reading and 200 printed copies and 250 additional copies of the English Edition.
- Purchase and mailing of the IAI-SCOPE book (Island Press has sent copies to the CRN I PIs, Co-PIs, IAI country delegates and SAC members).
- CRN 001 (Menezes, Tiessen) / CRN 003 (Luckman): three publications from dissertations finalized after program closure and a monograph on tropical tree-ring analysis.
- CRN 003 (Luckman): book-chapter in "Dendroclimatology: progress and prospects", Springer, plus 50 copies of the book to be distributed to regional dendro-labs and selected researchers/libraries.
- CRN 061 (Campos): publication of a 'Special Continental Shelf Edition' with ELSEVIER.
- Review and publication of workshop book on Application of Ecological Knowledge to Land Use Decisions (Costa Rica, Dec. 06).
- Other dissemination activities include the presentation of project results at international conferences.

Please refer to Annex 2 where you will find the details of the financial status of the program as of October 31, 2007.

b) Collaborative Research Network II (CRN - II)

The Collaborative Research Network II has been implemented, with all the grantees having signed the grant agreements and the Year 1 advances were transferred to the designated

accounts. The majority of the projects started in July 1^{st} , 2006, with one starting in June 1^{st} , 2006 and one starting September 1^{st} , 2006.

The Year 1 financial and technical reports were received in August, 2007, and approved expenses were reported to NSF via Fastlane on the quarter ended Sept. 30, 2007.

At the end of the past fiscal year, two projects (2005-Sarmiento; 2021-Sanchez) had formally requested the interim funds as established in the IAI Project Management Manual. Interim technical reports and cash flow reports were submitted and approved; interim funds were transferred to the Principal Investigator's accounts to continue the project activities during Year 1 of CRN II, based on cash-flow reports provided.

The ten other projects sent their Technical and Financial Reports on time, and for these, eight received advances based on the reported expenses, cash balance, and forecast for the following year. Two projects did not receive additional funds as the activities had been delayed due to problems and delays in signing the sub-awards with the institutions of the Co-PIs; additional funds will only be sent once they can prove the advance in the projects according to the approved work-plans and can provide a sound forecast for the remaining funds.

A control model for CRN II operations was developed. This model includes all the relevant information by project, institution, country, as well as reported expenses, schedules of payment, annual technical reports to the NSF, contact lists, and other critical information. This model will be updated by the F&A Office and is being published on a shared drive as an up-to-date and authoritative source of information on the projects and the overall CRN II program. This is an important tool for control of the project from the scientific and financial points of view.

Annex 3 provides a detailed list of approved projects and its annual budgets; the reported expenses for Year 1 and the balance of the projects and overall program can be found in Annex 4.

c) Training Institutes on Interdisciplinary Global Environmental Change Sciences in the Americas

The Training Institute Seed Grant (TISG) program associated with the 2005 Training Institutes terminated in February of 2007. For the period February 2006-February 2007 the IAI supported 8 seed grants at a level of US\$ 9,000-15,000/each (total IAI investment of US\$ 110,000). Also, Canada's IDRC funded one TISG.

The Seed Grants program has been completed and technical reports have been submitted and approved. Two projects had remaining resources (approximately US\$ 5,000) that will be returned to NSF. IAI terminated one TISG contract agreement with the original Principal Investigator and his home institution, the Universidad Mayor de San Simón, Bolivia. IAI recovered the funds and took over the administration of the project with two leading co-PIs from Peru and Venezuela.

IAI submitted a final technical report to NSF with an initial assessment of the program, which was approved by NSF.

The funding details of these programs can be found in Annex 5.

- d) IAI proposal to NSF for new Training Institutes
 - IAI submitted a proposal to NSF to support new Training Institutes. The proposal has requested US\$ 300,000 for 3 Training Institutes for the period 2007-2009. The Training Institutes will explore science themes that are policy relevant to promote the science-policy interface.
- e) Fundraising Efforts and Institutional Collaboration: MacArthur Foundation and IDRC

In an effort to diversify IAI funding base, the Institute approached the MacArthur Foundation, which has launched a program on Conservation and Sustainable Development. The announcement was a call for proposals inviting specific institutions to work with. The Foundation invited 3 organizations (CAN, IUCN and IAI) to submit a proposal to conduct an

assessment of the impacts of climate change on biodiversity in the Andes. Total funding available is for 2 years at a level of US\$450,000.

In July 2007 MacArthur announced that IAI's proposal passed its merit review. The final decision from the MacArthur's board of directors was favorable and we are now waiting on the MacArthur Legal Department to send us the contract.

In September 2007, IDRC also confirmed that the project proposal from IDRC was close to approval.

f) Small-Grants Program for Human Dimensions (SGP-HD)

In response a SAC recommendation to include more human dimensions research in its portfolio, the IAI has applied for and received a grant from the United States National Science Foundation (NSF) for US\$ 800,000 dollars for a 2-year period with which it has launched a new call for proposals under the Small Grants Program for Human Dimensions (SGP-HD award# 0642841) on 26 January 2007.

Six proposals were recommended for funding to the IAI Conference of the Parties (COP) at their 14th meeting in Manaus, Brazil, 14-15 June 2007. An additional two proposals were recommended for funding using funds under CRN II due to their inherent links to CRN II projects and following a recommendation made by the SAC during the CRNII review (July 2005). The COP approved the recommended package.

Grant agreements have been prepared for the approved projects. At the end of October 2007, four of the six project agreements have been signed and the funds for the first year transferred. The details of the program can be found on Annex 7.

g) Other activities planned for 2007/2008 – Training Institutes

4) Administrative Area

- a) Changes to Administrative Processes / Internal Controls
 - Employee Handbook

The changes to the forms and approved policies are being compiled and attached to the manual as a new annex. The manual is up-to-date with all changes.

Accounting Manual

One of the items included in the Management Checklist from the FAC is the Accounting Manual; a draft will be sent for review of the members of the FAC at the end of 2007.

Improvements in the Personnel Files

A weakness, detected and detailed in the Management Checklist, had been the opportunity areas in the employee personal files within IAI. The suggestions of the FAC have been incorporated in the files. The next review by the FAC will include this item.

- Attendance/Leave Control and Balances
 The web-based automated system is being tested. The prototype is expected to be functional and implemented in 2008.
- Brazilian Staff provided by INPE

Currently the IAI is paying nearly 50% of the salaries of the staff provided by Brazil, as the funding provided for these three positions is no longer enough to cover salaries at current market rates for the level of qualification required and detailed in the Host Country Agreement.

The situation has been discussed with INPE and the first steps towards a re-negotiation of the contract have been taken, however a final decision or outcome has not been attained. The president of the EC has been involved in the first contacts and discussion.

Recently, INPE informed IAI that the contract with Premium was being cancelled and a new bid for contracts would be put in place beginning 2008 and IAI would get the chance to review the bid details before it is published.

Internal Controls

The Internal Controls have yielded favorable reviews from the External Auditors and the FAC. These controls remain in place, being reviewed and updated where opportunities for improvement are detected. Currently there are no Internal Control Issues outstanding either from the FAC or the External Auditors.

5) External Audit of the IAI as of June 30, 2007

In October 2006, BDO Trevisan Auditores Independientes was chosen by the IAI to perform the external audit review of the IAI for the next three fiscal years (2005/2006, 2006/2007, and 2007/2008).

The audit for the fiscal year 2006/2007 was conducted during September 2007 and it included the review of accounting entries, internal controls, legal compliance, and opportunity areas in any of those. The results of the external audit review were favorable and they issued an opinion without qualification.

As requested by the FAC in May 2007, emphasis was made in a more detailed Management Letter from the independent auditors, as the one provided for the 2005/2006 financial statements was overly summarized and did not provided too many details.

The final report will not be received before the EC Meeting in Washington D.C.; however, based on the preliminary results presented to the FAC, and the resolution of the pending items after the audit, we expect an un-qualified report without internal control issues.

The previous qualifications raised by KPMG (former external auditors) were had been resolved in the 2005/2006 audit report.

The next audit by BDO Trevisan has been scheduled for September 2008; at this point the financial statements for the period July 2007 to June 2008 will be evaluated, as well as project management, internal controls and adherence to the Employee, Purchasing, and Project Manuals. We expect a favorable review in the next audit as well.
