Bolivia and Canada are hosting two thematic sessions, described below, during CoP-32 on Indigenous Science and Climate Adaptation and Resilience. Parties are invited to deliver brief presentations on their national initiatives and priorities, to highlight best practices and lessons learned, with the aim of promoting regional cooperation and learning.

CoP-32 Special session #1: Indigenous Global Change Science, first day of the CoP-32, 22 May 2024 at 2:40pm – 3:40pm UYT, at CoP-32 zoom link (registration link here)

Recognizing the significant value of Indigenous Science in advancing global environmental goals, including tackling the triple planetary crisis (climate, biodiversity loss and pollution), this session will build on the IAI's work to establish an Indigenous Peoples and Local Communities Advisory Committee that will make recommendations on the IAI Scientific Agenda, Strategic Plan, and annual work plan, with the goal of strengthening the work of the Institute and facilitating the equitable participation and contributions of Indigenous Peoples and Local Communities.

CoP-32 Special Session #2: Climate Change Adaptation & Resilience, second day of the CoP-32, 23 May 2024 at 3:20pm – 4:20pm UYT, at CoP-32 zoom link (registration link here)

Climate change and extreme weather events are impacting the region, with IAI members already facing record-breaking climate events. Wildfires, extreme heat waves and floods are becoming more frequent. The thawing of permafrost and rise in sea-levels are speeding up the erosion of our coasts. In short, climate-related disasters are impacting the very foundations of our region. It is essential that we support, leverage, and respect knowledge from all science, research, and innovation actors to tackle these challenges. Specifically, the knowledge and science from our

Indigenous and local communities can help us build a more resilient region to reduce the impacts of climate-related disasters and to protect and restore nature and biodiversity.

The workshop will bring with Indigenous people, engaging expert Indigenous knowledge keepers and Indigenous scholars from across Canada and Latin America in group discussions focused on Indigenous Languages and Biodiversity Indicators.

Biodiversity and Health Interlinkages, hosted by the Convention on Biological Diversity, 21 May 2024, 1:00pm – 2:00pm UYT.

This event will offer an in-depth exploration of the Convention on Biological Diversity (CBD) as a multilateral environmental agreement and its role in shaping national biodiversity strategies through the 2022 Kunming-Montréal Global Biodiversity Framework. It will provide insights into the forthcoming CBD COP16 in Cali, Colombia, in October 2024, highlighting the anticipated central outcome: a global action plan on biodiversity and health. Attendees will gain understanding of the interlinkages between biodiversity and human health, along with environmental-health risks and challenges. The event will provide an update on the intergovernmental process to draft a global action plan on biodiversity and health, following formal peer review and initial intersessional negotiations earlier in May.
