### **1. Opening Session**

The National Secretary of Science, Technology and Innovation of Panama, Jorge A. Motta, and Felix Wing Solís, Secretary General from the Ministry of the Environment of Panama, gave welcome speeches to country representatives.

### **2. Election of the CoP Bureau**

The CoP elected the following members as the Bureau for its Special Session: Maria Uhle from USA as Chair, Milagro Mainieri from Panamá as the First Vice-Chair and Fernando Méndez Gaona from Paraguay as the Second Vice-Chair.

### **3. Appointment of tellers**

The CoP elected Wilson Galo Henríquez, Ambassador from Ecuador in Panamá and Gregorio Pantaleón, Ambassador of Dominican Republic in Panamá, as tellers in the IAI Executive Director election process.

### **4. Approval of the Agenda**

The CoP approved the agenda of its special session.

### **5. Report by the Chair of the IAI Executive Council and IAI Executive Director Search Committee**

The Chair of the IAI Executive Council and IAI Executive Director Search Committee reported on the selection process and interviews conducted to reach the final short list of three applicants. She also explained how they selected one final candidate, that is presented for today's election process. (See report in Annex 1).

**Colombia:** expressed he fully trusts in the selection process and asked that for future elections the CVs of the Candidates be published in the IAI website.

### **6. Overview of the voting procedures**

The Chair of the IAI Executive Council and IAI Executive Director Search Committee, María Uhle, explained the criteria and procedures for the election of the IAI Executive Director. She said the candidate should not be a citizen or permanent resident of Uruguay and should be elected by a minimum of two-thirds majority of the quorum. It was agreed that the tellers should read each vote to the floor.

### **7. Report of the Credentials Committee**

The Credentials Committee informed the CoP that twelve delegations had submitted the official credentials to participate in the Conference: Argentina, Brazil, Canada, Chile, Colombia, Dominican Republic, Ecuador, Guatemala, Paraguay, Uruguay, Panamá, and USA. Required number of accredited Parties to constitute quorum was eight.

### **8. Election of the IAI Executive Director**

La CoP elected unanimously (with 12 votes) Marcos Regis da Silva as the next IAI Executive Director.

### **9. Adjourn**

The meeting was adjourned. Participants thanked the hosts for their hospitality.

### ***Report from IAI Executive Director Search Committee***

#### ***Committee members:***

#### ***Process***

IAI Executive Director search process was overseen by an 12-member committee consisting of representatives from various member countries as well as representatives from the Science-Policy Advisory Committee (SPAC), the Science Advisory Committee (SAC) and the IAI Directorate Staff.

The position description (Annex A) was posted on the IAI website on August 15, 2016. Several of our international partners shared this advertisement with their communities including Future Earth and START. The position was open to all qualified candidates except for citizens of Uruguay as stated in the Agreement to Establish the IAI.

Eligible candidates from the 2015 search process were contacted by the Search Chair and informed that a new process had been initiated and were encouraged to apply.

The committee received 25 applications by October 7, 2016 – the application deadline. All the information was contained on the IAI twiki and was password protected. The members of the committee evaluated each candidate according to the criteria (Annex B) agreed to by the CoP and Executive Council members. Each committee member provided a short list of up to 8 candidates identified as suitable for a teleconference interview. The chairs of the SPAC and SAC provided input from their members and Marcella Ohira provided the input from the IAI staff.

The search committee decided on a short list of 10 candidates that were provided the opportunity to interview with the committee during early November. The interviews were recorded with permission from each applicant and access to the recorded interviews was provided to all committee members as well as the members of the SPAC, SAC and IAI staff.

After review of the teleconference interviews, the committee invited 3 candidates for in-person interviews in Montevideo during the week of January 23, 2017. The interviews were recorded and all members of the search committee were given access to the files. The search committee discussed the candidates during a teleconference on 10 February 2017.

#### ***Recommendation***

The search committee recommends Dr. Marcos Regis da Silva as the next Executive Director of the IAI. As was stated during the CoP in Lima, a major challenge for the IAI has been engaging members of the CoP and galvanizing a regional perspective for the many challenges that the IAI science can help address. With the advent of the SPAC, the IAI is moving toward making the strong IAI science relevant and accessible to decision-makers in the region and the IAI requires an Executive Director with diplomatic and policy experience with a strong knowledge of how science can be used to inform decision-making and ultimately policy. Dr. Regis da Silva has the necessary background and experience to help the IAI move to the next level.

For over 25 years, he has worked within academia and the United Nations system as well as the secretariats of several international organizations. He has been instrumental in developing plans to move various organizations forward to meet challenging goals relevant to global environmental change. Biodiversity and ecosystem services have been the principal focus of his previous work. Currently, these are topics of great importance to the IAI member countries. Dr. Regis da Silva has also worked on global environmental change issues and their relation to trade within the Americas. He also provided a strong view on the need for open science and data sharing and provided several suggestions on how to position the IAI as a leader in the region for these efforts. During the interview, he presented a clear, ambitious vision for the IAI over the next decade and he recognized the need to engage members of the CoP to make these efforts successful.

He has experience in managing staff and providing a constructive, supportive work environment that is based on both team-work and individual responsibility and accountability.

The committee fully supports Dr. Marcos Regis da Silva for the position of Executive Director of IAI.
