# Core Budget and Country Contributions for FY 2025-2026 and Preliminary request 2026-2028

1. This document was prepared by the Directorate.

#### Introduction

#### Core Budget: Introduction

2. This document presents the request for the core budget and contributions from countries for the fiscal year 2025-2026 and the preliminary request for fiscal years 2026-2028.

#### The IAI Directorate: Synopsis

#### Positions, Consultancies, and Internships

- 3. During the 2024-2025 intersessional period, the administration of the IAI Directorate has implemented a set of administrative adjustments aimed at channeling processes, rationalizing the distribution of staff responsibilities and, as a strategic priority, optimizing the efficiency of spending.
- 4. The hiring of specialized consultancies is maintained as an institutional practice, reflecting both the specific demand for high-level professional services and the policy of cost containment linked to permanent personnel.

## Information and Communication Technologies

- 5. The work related to information technologies was reduced with the move of the Directorate to Panama. We only keep the cost for the SAP operating system backup service.
- 6. The functionality of the STeP Fellows database and the Expert Finder have been expanded, incorporating the option to search by category. These categories will be available on the new IAI website. The database of IAI-funded scientific articles has been reprogrammed so that a replica is available in the Harvard Dataverse.

#### Internal Controls

- 7. Internal controls are monitored and updated as needed and as appropriate. At the time of writing, there are no critical observations from the Finance and Administrative Committee and the External Auditors that have yet to be resolved.
- 8. The Financial and Administrative Section of the IAI continues to channel daily activities, financial reports, project monitoring and maintains internal control and satisfactory results of external audits.

# Budget Request for FY 2025-2026: Panorama

- 9. The comparison of the core budgets for 2025/2026 2024/2025 is presented in Table I.
- 10. The preliminary request for operating budgets for fiscal years 2026-2028 is presented in Table II.

## Salaries and benefits

11. This budget category includes the costs corresponding to salaries and benefits of contracted personnel, remaining unchanged with respect to the previous budget year.

# <u>Travel</u>

- 12. The FY 2025/2026 travel budget includes attendance at key meetings for the IAI strategy.
- 13. The IAI Directorate notes that the budget allocated for travel in the period 2025-2026 remains unchanged from the previous year. Therefore, it is recommended that, when receiving invitations to participate in events, the request for funding from the organizers is prioritized. This strategy will optimize the use of available resources and facilitate broader participation in key activities aligned with the strategic objectives of the IAI.

## **Operational costs**

14. This budget category mainly includes expenditures associated with staff training; the contracting of professional services, such as external audits, legal advice, information technology services, translation and accounting; the acquisition of office supplies; communication services; as well as operational support to the meetings of the Scientific Advisory Committee (SAC) and the Advisory Committee on Science and Policy (SPAC). In addition, adjustments were made to the costs related to information technology, in order to adapt them to the requirements of the new institutional headquarters.

#### Dissemination and outreach

15. The costs of the IAI's outreach activities have increased compared to last year, as the Directorate together with the Conference of the Parties considered it important to increase visibility and thus adjust the budget in order to be able to develop the projects and activities sponsored by the IAI. Compared to the previous year, the costs associated with the extension activities of the IAI show a reduction, mainly attributable to the larger adjustment made to the institutional web platform.

A number of new sections were developed on the IAI website to increase outreach and better inform Parties. These new sections include STeP information, a section with information on internships, and new sections related to the IAI Transdisciplinary Academy and the IAI-Pages Mobility Grants. The Executive Directorate, in coordination with the Conference of the Parties, has highlighted as a priority the strengthening of institutional visibility in order to optimize the development of projects and activities sponsored by the IAI. This objective is being materialized through the formalization of collaboration agreements with strategic partners and other related institutions.

# Executive Director Special Fund

17. The Executive Director's Special Fund remains unchanged from the previous fiscal year totaling \$54,000.

#### Party Contributions to the Core Budget

- 18. In this proposal, country contributions are presented based on the Finance Committee's proposal to increase by 20% compared to 2023-2024, and by 5% in subsequent years.
- 19. In view of the delay or non-payment of contributions by some Parties, the ability of the Directorate to fulfil its operational responsibilities is under pressure.
- 20. For the fiscal year 2024-2025, the Executive Directorate carried out an exhaustive work of contact with the focal points to follow up on the fulfillment of contributions. It also sent an official communication to these focal points, detailing the amount of the annual voluntary contribution corresponding to the current financial year.
